Assistant Division Director position: presently held by Richard Wilson, (completing his second full term May 31, 2019)

Please note the following dates.

December 3, 2018 — Nominations are DUE for Division Director and Assistant Division Director Positions. Nominations or announcements must be accompanied by a one-page resume of the candidate's membership in NSP that demonstrates the candidate's eligibility for office and a one-page statement of the candidate's platform. All nominations, other than self-nominations, must be accompanied by written acceptance of the nomination signed by the nominee.

January 7, 2019— Division Director and Assistant Div. Director candidates list finalized by Elections Committee.

January 21, 2019—List of candidates for Division Director and Assistant Div. Director, their resumes and platforms to be posted to the FWD web site.

February 4, 2019—Date of Election, ballots will be distributed to electorate (via email).

March 4, 2019— Date all ballots to be received/postmarked by for Division Director and Assistant Div. Director positions.

March 25, 2019—Results announced (sooner if all eligible ballots are returned or no other candidates see FWD Bylaws 5.4.2.1a)
