**GOALS UPDATE FROM 8/2017**

- Lower learning curve for members accessing NSP website, paying dues, enrolling in courses, accessing records = YES
- PR's "Managing Patrol Roster" BETTER. All patrols registered by Nov. 15 = MOST, all but 5.
- Supervisors, Advisors, RD's have accurate/complete access to Course Reports and Rosters. YES
- IOR's and IT's closing courses two weeks after End Date. BETTER (See Course Delinquencies)
- Alumni registration by Regions. IN PROCESS: Regions set up, enrollment form asks for Patrol/Region, Tim Viall canvassing Alumni to gather data.

**ISSUES and RESOLUTIONS:**

- Supervisors, Advisors, PR's and members at all levels are using the system successfully. Members are paying their dues online, enrolling in courses, and accessing their training records on their profile. It is by no means perfect, but once a member learns the process, the end result is more efficient and accurate.
- 80% + who are OEC delinquent have paid their 2018 dues. A NSPS member can not use their OEC certification to patrol if it is delinquent.
- 25 members who are registered as Alpine Patrollers either as Volunteer or Paid and have not taken OEC. NPS Board has chosen to table the issue this season. P&P's, "Members must be registered in an OEC class or hold current credentials in OEC" (page 38).
